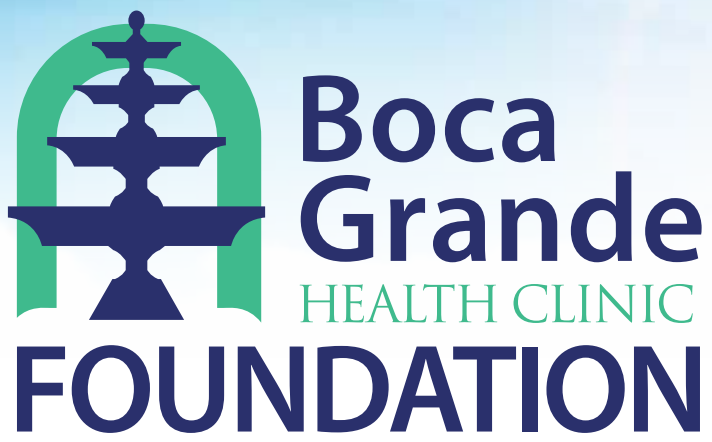

I am happy to report that the Foundation is well-positioned to fulfill our mission of supporting the Boca Grande Health Clinic, our incredible community resource dedicated to providing high-quality, compassionate healthcare to the island. Through primary and preventive care, chronic care management and healthcare education, our Clinic is committed to the health and well-being of Boca Grande.

**During the past year, truly a challenging time for all, the Foundation has observed many successes.**

- We navigated a very smooth transition of leadership in the Foundation office. In April, Mary Anne Hastings retired after serving as Executive Director for 15 years, and Cannon Wenzel was appointed to succeed her. Yuliy Fedoryshyn joined the staff as Executive Assistant.

- The Annual Giving Campaign raised more than \$1,400,000. It was the most successful campaign in the history of the Foundation, and we extend a very sincere thank you to our many generous donors.
- The Hank Wright Auction was held virtually due to the pandemic, and it was a tremendous success, raising over \$240,000. The Clinic identified their greatest immediate need this past year as Personal Protective Equipment and during the auction, an additional \$50,000 was raised directly for PPE. The auction will move to the Fall season beginning in November of 2022.
- Our Endowment grew appreciably to over \$60 million. We received a significant Planned Legacy gift and several major pledges, and our investment returns have been rewarding. The Board developed and approved an Endowment Spending Policy designed to assure that we can continue to meet anticipated financial needs of the Clinic going forward.
- The Foundation is now sponsoring our Healthnetwork GOLD support plan for over 350 major donor families. Healthnetwork offers our members unique access to the most prestigious medical institutions in the United States.
- Bob Freeman retired in April after serving three years as Chair of our Board, and I would like to thank him for his enthusiastic dedication to the Foundation. Under Bob's leadership, our donor base was substantially broadened, and we surpassed the recent Capital Campaign goal of \$5 million.



In the coming year, the Clinic will celebrate its 75th Anniversary. For this occasion the Foundation will host a gala street party on April 7, 2022, to revel in this momentous occasion and to thank our entire island community for their support. The Hank Wright Golf Tournament will be held the next day, on April 8, 2022, at the Lemon Bay Golf Club.

BGHC has completed a comprehensive study of its staffing, operations and procedures and will be rolling out a 5-Year Master Plan to guide its strategic programs over the next few years. There will be some new and exciting initiatives designed to better position the Clinic to serve our community. This includes the introduction of team-based patient care model and partnerships with local providers. The needs of our Clinic will grow, and the Foundation must be prepared.

We very much appreciate your commitment in partnership with the Foundation to the continuing success of the Boca Grande Health Clinic.

In January of 2021, Carol Dooge began experiencing a burning sensation on her tongue and an accumulation of sores in her mouth. The mysterious pain was frustrating and causing her to lose weight. Various doctors (and even a dentist) had suggested that she had Burning Mouth Syndrome, but there was a chance it could be an auto-immune disease, such as Sjogren's Syndrome. After a biopsy and an inconclusive test result, Carol called Healthnetwork to reach a wider audience of experts. Carol spoke with Jennifer, a Healthnetwork Medical Coordinator, who offered an opportunity to consult with physicians at Tampa General Hospital.

"At Tampa General, I saw a Rheumatologist and an Ear, Nose & Throat (ENT) specialist. Everyone there was so helpful and concerned. Another biopsy was done by the ENT specialist, and they later reported that the results did not definitively indicate Sjogren's Syndrome," added Carol gratefully.

Throughout all Carol's appointments, Jennifer followed up with her to ensure she was getting the care and answers she needed. I really appreciate the effort that the Boca Grande Clinic team, Jennifer from Healthnetwork and the different specialists at Tampa General put into my care. It really made a difference to me." Carol said.

Laurie also recalled a few times they had reached out to Healthnetwork for various family members who were able to receive care at different hospitals across the country. One serious health issue involved his daughter Janet. She had a routine colonoscopy and the subsequent polyp removal led to a dire infection. Janet ended up in her local hospital's ICU in an induced coma. In all she was hospitalized for 50 days and had undergone five surgeries. Over the next 10 months she continued to have significant medical issues. "It was then that we got Healthnetwork involved. One of your coordinators quickly arranged for Janet to see physicians at the Mayo Clinic in Rochester. We all were impressed by the experts she met there. She had another surgery and the care she received there put her well on her way to recovery and regaining her life."

Laurie and Carol have nine children and 23 grandchildren in Michigan, Colorado and California. They take comfort in knowing that should something happen to any one in their family – Healthnetwork is ready and able to step in with resources. Laurie shares "I believe in the good that you do and will continue to support Healthnetwork and the Boca Grande Health Clinic. Both of you have proven to be an important contributor to the health of our family!"

## Good Things are Happening at the Clinic

For almost 75 years, the Boca Grande Health Clinic has been serving the healthcare needs of Island residents and businesses. The last 14 months that I've had the honor of serving as CEO have been among the most rewarding times in my executive career. Success metrics, chief among them, patient satisfaction continue to trend up, thanks in large part to the work of our dedicated doctors, nurses, and staff.

It's been a busy year and half at the Clinic. I want to thank the staff, physicians, board, and community for their understanding and partnership in making these changes happen – all while navigating a pandemic.

Our education series will be presented both virtually and in person when possible and will cover a variety of topics coming from community and patient suggestions.

The Clinic is entering a new phase of commitment, reinforcing our mission and values, and setting a vision for a very bright future. A five-year strategic plan to enhance our facilities and elevate our services will be unveiled in the coming months and you can look forward to improved care and referral services as we cement formal partnerships both on and off the Island.

Next year will be an even bigger year for the Clinic. We mark our 75th year of providing care on the Island. We are planning many fun and exciting ways to celebrate our history, while we move the Clinic into the next chapter of exceptional care and service.
